SUGGESTION OF MOOTNESS


Appellee Commonwealth of Pennsylvania hereby suggests that the case is moot as to Viviette Applewhite, averring as follows:

1. Viviette Applewhite claimed that she did not have a photo identification card, as required by law, and so would be unable to vote in November.
2. Ms. Applewhite was issued a non-drivers photo ID by the Pennsylvania Department of Transportation on August 16, 2012, which is valid for purposes of voting. See attached Declaration of Janet L. Dolan.

WHEREFORE, the appeal should be dismissed as moot as to Appellant Viviette Applewhite.
